

## **NFX Reports Metrics Through September 2020 Trading Events**

Starting with the inaugural Natural Fibre Exchange (NFX) trading event in May 2018, 60 trading events have occurred fortnightly through September 2020.

Since the inception of NFX, nine sellers have offered lots, ten buyers have submitted bids, and nine buyers have won lots. Volume sold has totalled 8.3 million nett kg in 2,378 lots.

Per trading event, the number of lots offered has ranged from 8 to 102, with offered nett kg ranging from 56,252 to 378,611 kg. Across all trading events, 76 percent of the offered lots and 73 percent of the offered nett kg have sold.

As a buyer you also must have pre-approval from a seller to bid on that seller's products.
